The Chickamauga City Board of Education held its regular monthly meeting on Monday, April 13, 2020 at 5:15 p.m. The meeting was held at Gordon Lee High School Media Center to allow for social distancing due to COVID-19. Members present were: Chairman, D.A. Jewell, V; Vice Chairman, Grant Parrish; Janet Landers, Cindy Roberts, David Askew and Melody Day, Superintendent.

Chairman Jewell called the meeting to order and asked Vice Chairman Parrish to give the invocation.

Chairman Jewell offered condolences on behalf of the Board to the Andrews family on the passing of Judge Gary Andrews. He was a graduate from Gordon Lee High School and was always a great supporter of the school system.

Chairman Jewell welcomed the visitors to the meeting: Diane Miller.

Superintendent Day recognized the following individuals/groups: At the HOSA State Conference, Will Carswell finished in the top 16 in the state for Sports Medicine, and Emma Minghini, Regan Thompson, and Hunter Richie finished in the top 16 in the state for Biomedical Debate. HOSA State Conference has over 4,000 members competing at the State Conference. The Chickamauga City Board of Education received an Award of Distinction for Excellent Financial Reporting for FY2018 by Georgia Department of Audits and Accounts.

Vice Chairman Parrish made the motion to approve the April Board Agenda. Ms. Landers seconded the motion, and the motion carried.

Ms. Landers made the motion to approve the following cafeteria prices for School Year 2020-2021 in order to comply with the School Lunch Act and "Equity Pricing". Student breakfast \$1.85; elementary student lunch \$2.80; middle/high student lunch \$2.95; staff breakfast \$2.25; staff lunch \$3.35; visitor breakfast \$3.00; visitor lunch \$5.00. With a second from Vice Chairman Parrish, the motion carried.

Ms. Landers made the motion to approve the following expenditure exceeding \$5,000. ServoPro of Chattanooga in the amount of \$7,039.38 for water restoration at the Gordon Lee High School Baseball Building. Vice Chairman Parrish seconded the motion, and the motion carried.

Vice Chairman Parrish made the motion to recommend maintaining the current millage rate of 14.25 mills for 2020-2021. With a second from Ms. Landers, the motion carried.

Ms. Roberts made the motion to adopt a resolution certifying the completion of Gordon Lee Middle/High Facility Addition Project. Mr. Askew seconded the motion, and the motion carried.

Ms. Landers made the motion to approve the updated Organizational Chart. With a second from Mr. Askew, the motion carried. Attachment 706A
