The Chickamauga City Board of Education held its regular monthly meeting on Monday, January 8, 2018 at 5:15 p.m., in the Board Room. Members present were: Chairman, D.A. Jewell, V; Vice Chairman, Grant Parrish; David Askew, Billy Ellis, Janet Landers and Melody Day, Superintendent.

Chairman Jewell called the meeting to order and asked Vice Chairman Parrish to give the invocation.

Chairman Jewell turned the meeting over to Superintendent Day for the 2018 election of officers.

Vice Chairman Parrish made the motion to approve the January Board Agenda. With a second from David Askew, the motion carried.

Mr. Askew made the motion to approve the January Consent Agenda containing the following items: Minutes of the December 11, 2017 Regular Meeting; Approve field trips: Gordon Lee High School-AP Biology Class to Skidaway Island, GA, March 21-23, 2018. Approve Fund Raisers: Gordon Lee High School-Multi-Fandom Club bake sale each Tuesday during break, January and February 2018; HOSA-collect scarves, gloves, and toboggans for community shelters, January 2018; HOSA-donate/raise money for Lymphoma and Leukemia Society through the "Pennies for Patients" program, February 2018. With a second from Mr. Ellis, the motion carried.

Financial reports presented for approval were: General Fund, October 2017; Bus Account, October, November, and December 2017; SPLOST 2011, October, November, and December 2017; SPLOST 2016, October, November, and December 2017; General Obligation 2016, October, November, and December 2017; School Nutrition, July, August, September, and October 2017; Chickamauga Elementary School, October, November, and December 2017; K.I.D.S. After Care Program, October, November, and December 2017. Vice Chairman Parrish made the motion to approve the financial reports as presented. With a second from Ms. Landers, the motion carried.

Michael Green, President of the Gordon Lee High School FFA Alumni, addressed the Board concerning National FFA Week, February17-24, 2018.

Ms. Landers made the motion to designate the law firm of Harben, Hartley & Hawkins, LLP of Gainesville, Georgia as general legal counsel for 2018 with the proviso that for local issues, local counsel may be obtained. With a second from Vice Chairman Parrish, the motion carried.

Mr. Ellis made the motion to approve the Adidas Team Agreement with Gordon Lee High School, beginning July 1, 2018 and ending June 30, 2023 for footwear, apparel, and accessories. With a second from Vice Chairman Parrish, the motion carried.

Mr. Askew made the motion to approve the following expenditure exceeding \$5,000: CDW Government for computer system back-up in the amount of \$6,480. Mr. Ellis seconded the motion, and the motion carried.

With no further business, Chairman Jewell called for a motion to adjourn the meeting. Vice Chairman Parrish made the motion to adjourn, with a second from Mr. Ellis. Motion carried, and the meeting was adjourned at 6:45 p.m.
