Copies of the Professional Learning Report FY16 were given to each Board Member.

Ms. Landers made the motion to maintain the current tuition rate of \$800 per out of district Georgia students, with a cap of \$2,400 per family of three or more students. With a second from Mr. Askew, the motion carried.

Mr. Ellis made the motion to approve the purchase of a 2006, 14 passenger bus for \$28,076, and to set a mileage reimbursement rate of \$1.00 per mile. Vice Chairman Parrish seconded the motion, and the motion carried.

Mr. Askew made the motion to approve the purchase of a 2017 Ford Explorer for \$30,829.72, less trade-in. With a second from Ms. Landers, the motion carried.

Mr. Ellis made the motion to rescind the action declaring a 2006 Chevrolet C1500 truck surplus, and to declare a 1995 Ford F-150 surplus. Vice Chairman Parrish seconded the motion, and the motion carried.

Vice Chairman Parrish made the motion to approve the purchase of 70 EDCO Recordex interactive boards and accessories for the amount of \$299,954 which includes installation and four training days. With a second from Mr. Askew, the motion carried.

Superintendent Day informed the Board that a thank you letter for the donation to the Cherokee Regional Library had been received.

- Accept the following resignations: Teresa Lee, Chickamauga Elementary teacher, and Jared Willerson, Gordon Lee High teacher, effective at the conclusion of the 2016-2017 school year.
- Employ Robyn Dockery for a teaching position at Chickamauga Elementary for the 2017-2018 school year. Vice Chairman Parrish made the motion to approve employment as presented. With a second from Mr. Ellis, the motion carried.
- Approve Rickey Murdock, Facility Maintenance employee, as Transportation and Maintenance Manager with salary comparable to current including all supplements. Mr. Ellis made the motion to approve the position. Vice Chairman Parrish seconded the motion, and the motion carried.
- Approve Certified Central Office and School Administrators for 2017-2018 school year. Vice Chairman Parrish made the motion to approve the positions as presented. With a second from Mr. Ellis, the motion carried.

Chairman Jewell recommended Superintendent Day be reimbursed in the amount of \$8.97 for the period of February 14-March 12, 2017. There were no objections.

With no further business, Chairman Jewell called for a motion to adjourn the meeting. Mr. Ellis made the motion to adjourn, with a second from Vice Chairman Parrish. Motion carried and the meeting was adjourned at 7:53 p.m.
